HOOKER COUNTY BOARD OF COMMISSIONERS REGULAR MEETING October 9, 2025

The Hooker County Board of Commissioners held a regular monthly meeting at 3:30 p.m. in the courthouse on October 9, 2025. Present were commissioners Bryan Crisp, Thad Emerson and Julie Kraye. Also present during the meeting were Jessica Hampton, Crystal Hardy, Todd Yost, Mike

Minutes from the September 11th, 2025 regular meeting and the September 11th Budget Hearing and Tax Request Hearing were reviewed. Thad Emerson made a motion to approve the minutes as presented, Julie Kraye seconded. Roll call vote, three ayes, motion carried. Chairman Bryan Crisp announced the Public Meetings Law posted in the boardroom and copies of it and the agenda are available for the public.

The claims on file were audited by the board. Thad Emerson moved and Bryan Crisp seconded the motion that the audited claims be allowed and warrants from the various county funds be issued for their payment. Roll call vote, three ayes, motion carried. Approved claims are listed below. Roads were discussed and monthly expenses reviewed. Three road superintendent applications were reviewed. Bryan Crisp made a motion and Julie Kraye seconded the motion to appoint John Copland with Dickinson Land Surveying as the Hooker County Road Superintendent starting January 1, 2026. Roll call vote, three aves, motion carried.

Mike Baum provided a road update. North Able Rd road work is complete and the road department has started on the Haney Rd. Repairs were made on the loader.

The new road building heater was installed as well as the propane tank. The office needs to be completed, water hooked up and electrical finished. Bryan Crisp recessed the regular meeting at 4:00 p.m. for Board of Equalization. Meeting reconvened at 4:03 p.m.

Julie Kraye made a motion to designate Crystal Hardy as the person casting the ballot for the NACO election in December. Thad Emerson seconded the motion. Roll call vote, three ayes, motion carried.

Clerk Jessica Hampton reported that the auditors were in office and the audit should be complete for the November meeting. Hampton requested that the November meeting be moved to Tuesday, November 4th at 1 p.m. for County Government Day. Emerson requested that the December meeting be moved to Thursday, December 4th at 3:30 p.m. No objections, meetings will be moved and published accordingly. Correspondence was distributed to the board.

Crystal Hardy presented the treasurer's report, provided an update on delinquent taxes. Bryan Crisp made a motion to approve the treasurer's report and Julie Kraye seconded the motion. Roll call vote, three ayes, motion carried.

Sheriff Todd Yost provided a sheriff's report.

The NRIN Resolution was reviewed, it was Sheriff Todd Yost's opinion that becoming a member of NRIN is not necessary at this time. The NRIN Resolution has been tabled.

Library budget worksheet was reviewed.
